The Dividend, if approved will be payable to those Equity Shareholders, holding shares either in physical form or in dematerialized form on the close of Wednesday, 11th September, 2024;



- Mr. Parmod Kumar Duggal (DIN: 02382912), Whole-time Director and Chief Executive Officer has been reappointed and designated as Executive Director & Chief Executive Officer of the Company w.e.f. 5th August, 2024 for a period of three years, subject to the approval of the Shareholders at the ensuing Annual General Meeting. (Annexure-C);
- (7) The Board has considered payment of Commission to the non-executive Independent Directors, subject to the approval of the Shareholders at the ensuing Annual General Meeting of the Company;
- (8) The Board Meeting commenced at 11.30 am and concluded at 2.10 pm.

Report on the Audit of Standalone Financial Results

Opinion

- 1. We have audited the Standalone Annual Financial Results of Subros Limited (hereinafter referred to as the "Company") for the year ended March 31, 2024, which are included in the accompanying 'Statement of Unaudited / Audited Standalone Financial Results for the Quarter and Year Ended March 31, 2024', the Standalone Statement of Assets and Liabilities and the Standalone Statement of Cash Flows as at and for the year ended on that date (hereinafter referred to as "Standalone Financial Results"), attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the 'Listing Regulations') which has been initialled by us for identification purposes.
- 2. In our opinion and to the best of our information and according to the explanations given to us, the aforesaid Standalone Financial Results:
 - (i) are presented in accordance with the requirements of Regulation 33 of the Listing Regulations in this regard; and
 - (ii) give a true and fair view in conformity with the recognition and measurement principles laid down in the applicable accounting standards prescribed under Section 133 of the Companies Act, 2013 (the "Act") and other accounting principles generally accepted in India, of Profit and Other Comprehensive Income and other financial information of the Company for the year ended March 31, 2024 and the Standalone Statement of Assets and Liabilities and the Standalone Statement of Cash Flows as at and for the year ended on that date.

Basis for Opinion

3. We conducted our audit in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Act and other applicable authoritative pronouncements issued by the Institute of Chartered Accountants of India. The Board of Directors of the Company are responsible for maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making

judgments and estimates that are reasonable and prudent; and the design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring accuracy and completeness of the accounting records, relevant to the preparation and presentation of the Standalone Financial Statements that give a true and fair view and are free from material misstatement, whether due to fraud or error, which have been used for the purpose of preparation of the Standalone Financial Results by the Directors of the Company, as aforesaid.

- 5. In preparing the Standalone Financial Results, the Board of Directors of the Company are responsible for assessing the ability of the Company to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Board of Directors either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.
- 6. The Board of Directors of the Company are responsible for overseeing the financial reporting process of the Company.

Auditor's Responsibilities for the Audit of the Standalone Financial Results

- 7. Our objectives are to obtain reasonable assurance about whether the Standalone Financial Results as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these Standalone Financial Results.
- 8. As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:
 - Identify and assess the risks of material misstatement of the Standalone Financial Results, whether

Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Company to cease to continue as a going concern.

- 1 The above financial results were reviewed by the Audit Committee at their meeting held on May 22, 2024 and subsequently approved by the Board of Directors at their meeting held on May 23, 2024.
- 2 The financial results of the Company have been prepared in accordance with the recognition and measurement principles of Indian Accounting Standards ("IND AS") as notified under the Companies (Indian Accounting Standards) Rules, 2015 and relevant amendment rules issued thereafter.
- 3 The Company's operations comprise of only one segment i.e. Thermal products. Hence, no further information is required to be given in respect of segment.
- 4 The Board of directors have recommended a final dividend or Rs. 1.80/equity share (90% on face value of equity shares of Rs. 2 each) for the year ended March 31, 2024. The dividend is subject to approval of shareholders at the ensuing Annual General Meeting of the Company.
- In financial year (FY) 2019-20, the tax laws were amended, providing an option to pay tax at 22% plus applicable surcharge and cess ("New Rate") effective April 1, 2019, with a condition to surrender specified deductions / incentives.

 During the FY 2023-24, the Company has utilized the entire Minimum Alternate Tax credit balance and will opt for the New Rate from FY 2024-25. The Company remeasured its deferred tax balances accordingly with an impact (deferred tax credit) of Rs. 140.18 Lakhs and Rs. 664.59 Lakhs for the quarter and year ended March 31, 2024, respectively.
- 6 Figures for the quarters ended March 31, 2024 and March 31, 2023 represent the difference between the audited figures in respect of full financial years and the published figures for the nine months ended December 31, 2023 and December 31, 2022, respectively which were subjected to limited review.

The Company remeasured its deferred tax balances accordingly with an impact (deferred tax credit) of Rs. 140.18 Lakhs and Rs. 664.59 Lakhs for the quarter and year ended March 31, 2024, respectively.
